NOTES:

1. This Price List applies to citizens of the Republic of Kazakhstan enrolling in Master's degree programmes on a tuition-fee basis in the 2026–2027 academic year.
2. The tuition fee established by this Price List is the tuition fee for one academic year under the relevant Master's degree programme.
3. The payment procedure and deadlines are determined by the educational services agreement, the University's internal regulatory documents, and the legislation of the Republic of Kazakhstan.
4. Academic groups (streams) are formed by the University taking into account actual enrolment results, the number of students, the content of the educational programmes, staffing capacity, and the requirements of the relevant educational programmes, the required number of academic credits, and the intended learning outcomes are maintained.
5. For graduates of Bachelor's and Master's degree programmes of JSC «Kazakh Ablai Khan University of International Relations and World Languages», regardless of the year of graduation, who enrol in Master's degree programmes on a tuition-fee basis, a special tuition fee for the first academic year may be established under the Alumni Program in accordance with the procedure and conditions determined by a separate internal act of the University. For Master's degree graduates, the special conditions of the Alumni Program apply when enrolling in a different Master's degree programme.

6. Special tuition terms, financial support measures, and other special payment terms are established in accordance with the University's internal acts and are reflected in the educational services agreement.
7. The cost of retaking academic disciplines (modules) in cases requiring repeated completion of the discipline's educational programme, the cost of completing additional disciplines (modules) and academic credits to eliminate academic differences, as well as the cost of other additional educational services provided on a tuition-fee basis, shall be determined by separate price lists and/or internal acts of the University in accordance with the legislation of the Republic of Kazakhstan and the University's Academic Policy.
