## Rules of Stay of Foreign Students in the Republic of Kazakhstan

International students must register their stay in the Republic of Kazakhstan (RK) within 5 days upon arrival. To do this, international students must visit the International Students Department on the first day of arrival.

- The student is responsible for registration and visa expenses.
- A foreign student is required to have his passport and the Student ID with him/her outdoors during the whole stay in Kazakhstan. If you have handed over your passport to the Migration Police for registration, you need to have the Student ID and "Spravka" of the University instead of it and keep it until you receive your passport back.
- If a student decides to leave Kazakhstan for an abroad trip (vacation at home country, travel etc.) during the period of his/herStudent Visa, the student mustnotifyhis supervisor and the InternationalRelations Office in writing within 2 week prior the trip.
- The student is obliged to submit the passport to the Department for re-registration within 5 days uponcoming back. If a student fails to come to the International Students Department within 5 days, the penalty, trial or deportation from the country may take place.
- A student is not recommended toleave Almaty without his/her passport, even if he/she has an Ablai KhanUniversity ID and "Spravka".
- After a change of the foreign student's address he/she within two days must submit passport to the International Students Department work with foreign students for change of the registration card.
