10. PROFILE AND EDUCATIONAL GOALS OF THE PROGRAM

The educational program of doctoral studies "8D02322 - Foreign Philology" is implemented by the Department of Theory of Foreign Philology of Ablai Khan Kazakh State University of International Relations and International Languages and is a set of the main components of education (volume, content, planned results), forms of certification, which are given in the form of a general description of the educational program, curriculum, calendar curriculum, work programs of disciplines, programs of educational and industrial practices, parameters assessment, methodological materials, and other components included in the educational program.

Pedagogical practice is carried out in order to form practical teaching skills in higher school.

Research practice contributes to the improvement of skills in conducting scientific work - collection, systematization, experiment, analysis of the studied material and its use in writing a doctoral dissertation and scientific articles.

The purpose of the educational program "8D02322 - Foreign Philology" is to train doctors in the field of foreign philology that meets modern requirements for specialists representing foreign language and foreign philology education.

The Bachelor's Programme in Foreign Philology trains highly qualified specialists in a wide range of philological fields who are able to engage in scientific, pedagogical, managerial and expert activities.

The educational program "Foreign Philology" is aimed at developing personal qualities in doctoral students, namely the ability to navigate in the system of universal values, take into account the value and semantic orientations of various social, national, religious, professional communities and groups in society, be guided by ethical norms that involve respect for the uniqueness of a foreign culture; the development of a culture of thinking, the ability to analyze, generalize information, set goals and choose ways to achieve them, master the culture of oral and written speech, the formation of socio-cultural and intercultural communication skills that ensure the adequacy of social and professional contacts.

The program is also aimed at developing such professionally significant qualities as the desire for professional self-improvement, the development of logical thinking, accuracy of perception, high culture, tolerance, a stable moral position, creative imagination, the ability to conduct a constructive, professional dialogue in situations of interethnic, interfaith, international contexts of interaction, to carry out scientific, teaching, educational, editorial, translation, cultural and organizational activities.

In times of the use of new technologies and the ever-expanding digital space, access to foreign language information, its comprehensive professional understanding and effective application is one of the decisive factors that ensure the development of modern society.

11. EXPECTED LEARNING OUTCOMES

The educational program is aimed at achieving learning outcomes through the formation of key and professional competencies necessary for the training of scientific and pedagogical personnel in the field of higher and postgraduate education, as well as scientific activities. The training program for doctoral students in the field of "Foreign Philology" is developed in accordance with the requirements of the Dublin descriptors of the second level, which involve the following competencies:

Ability to apply various modern scientific research methods to objects of linguistics and literary criticism; Ability to draw a line between correct and incorrect hypotheses, to find the most rational ways to solve scientific problems;

The ability to conduct research not only to prove the correctness of a hypothesis, but in order to obtain data important for science;

Ability to trace the development of language in the diachronic aspect and the influence of historical events on certain synchronous sections;

Ability to apply the acquired theoretical knowledge in the methodology of foreign language education and in research activities.

For three years, the doctoral student receives knowledge about the latest trends in the scientific philological field, as well as improves the chosen foreign language to a high academic level.

The proposed program corresponds to the substantive tasks of the educational process, providing comprehensive training of doctoral students in the specialty "Foreign Philology". The curriculum includes disciplines that reflect current trends in the field of linguistics, literary criticism and intercultural communication, as well as the requirements of state educational standards for postgraduate education.

Upon successful completion of this program, the graduate:

Training within the framework of the program is built on a modular basis. 1 module consists of, as a rule, 30 credits. During one semester, the student's teaching load cannot exceed 2 modules. The final state certification of students is carried out in the form of defending doctoral dissertations.

Particular attention will be paid to the development of distance learning, to the wide public recognition and certification of educational and scientific products 8D02322 "Foreign Philology". It is planned to attract applicants and foreign students to enter the doctoral program of Ablai Khan Kazakh University of International Relations and Languages and thereby increase the number of applicants to this program.

Conclusion

When developing this educational program, the integration processes taking place in the world, international experience in the development and implementation of similar educational programs, as well as the universalization of approaches of leading foreign and domestic universities were taken into account.

The plan for the development of the educational program is aimed at improving the quality of training specialists in the field of foreign philology by entering the world educational space.
