#### NOTES

1. This Price List shall apply to citizens of the Republic of Kazakhstan admitted on a fee-paying basis to Bachelor's Degree Educational Programmes on the basis of general secondary education (completion of Grade 11) for the 2026–2027 Academic Year.
2. Language Tracks, First Foreign Languages, Second Foreign Languages, Academic Groups (Cohorts), and Individual Learning Pathways shall be determined and organized by the University, taking into account admission results, the availability of academic staff, the minimum number of enrolled students, the requirements of the Educational Programmes, and the University's organizational capacity.
3. Under Educational Programme **6B01708 "English Language (IP)"**, the programme provides intensive English language instruction without the option of selecting a Second Foreign Language.
4. For Educational Programme **6B03201 "Journalism"**, the minimum UNT threshold score required for admission, transfer, and reinstatement shall be determined on the basis of the results of the creative entrance examination in accordance with the legislation of the Republic of Kazakhstan and the Admission Rules of JSC "Kazakh Ablai Khan University of International Relations and World Languages".
5. Admission, study, transfer, reinstatement, tuition fee payment, and other conditions governing the provision of educational services shall be carried out in accordance with the legislation of the Republic of Kazakhstan, the Admission Rules of JSC "Kazakh Ablai Khan University of International Relations and World Languages", the University's Academic Policy, other internal regulatory documents of the University, and the Educational Services Agreement.
6. Where the number of enrolled students is insufficient to establish a separate Language Track, the University reserves the right to form combined Academic Groups (Cohorts) or to offer a student an alternative Language Track available within the respective Educational Programme.
7. The University reserves the right to update the list of available Language Tracks and Second Foreign Languages within the respective Educational Programme, taking into account the availability of academic staff, the minimum number of enrolled students, the requirements of the Educational Programme, and other organizational conditions governing the delivery of the educational process.
